Political

The absence of a solution to the political deadlock and continuing legitimacy crisis over the GNU's mandate continue to define the context of heightened political uncertainty. In the current context, there are two political initiatives at odds with one another. The pro Al-Meshri bloc within the High Council of State (HCS) recently voted in favour of the House of Representatives' (HoR) 13TH constitutional amendment, while key international actors have announced support for the political initiative proposed by UN SRSG Abdoulaye Bathily.

Intense political manoeuvring will likely define the next few weeks against the backdrop of Bathily's proposed formation of a High-level Steering Panel for Libya. Key contentious issues such as the eligibility of dual nationals and military officials to run for president will continue to divide Libyan stakeholders and undermine progress towards a solution to the stalemate.

The UN SRSG's proposal is already facing resistance from key domestic actors such as the HoR. Consequently, Whispering Bell assesses actors opposed to the UN-led initiative will double down on their campaigns to form a new unified government as a hedge against the UN push to establish a new dialogue forum. In turn, renewed efforts to form a new government will mount the pressure on the GNU and PM Abdul Hamid Dbeibah. Amid US pressure to hold elections, Dbeibah may be compelled to reshuffle his cabinet and/or organise limited legislative elections. Of note, Dbeibah announced the formation of a government committee to implement and coordinate elections on 09 March, while Bathily provided further details on his proposal to form a High-Level Steering Panel for Libya in a press briefing on 11 March.

Security

Tripoli is operational and continues to present a relatively permissive operational environment. Sporadic incidents will continue to define security atmospherics in the western region. From a security standpoint, the status quo and stable atmospherics are set to remain as is in Tripoli. Low-impact and localised flashpoints outside government offices are possible but are unlikely to escalate or impact business operations. Targeted attacks against HoR MPs, HCS members, and other political figures are likely as political tensions peak over the next few weeks.

Oil & Gas

Disruptions to production are likely despite evidence the LNA is yet to support a coordinated oil blockade. In his latest visit to Libya, US Central Intelligence Agency (CIA) Director William Burns allegedly reiterated to Haftar the importance of safeguarding oil and gas facilities and production.

The Internal Security Agency (ISA) published video footage of the confessions of a local female and a male US national detained on charges of promoting christianity during which they confessed to the charges against them on 13 April. The ISA identified the US national with the initials "SBO" who works as an assistant director at the <u>Gateway Center</u>; an English language school in Tripoli's Zawiyat Al-Dahmani area. The Agency stated that the US national, along with his spouse, were part of an organisation promoting christianity called "Assemblies of God", encouraging Muslims to convert to Christianity. The US national confessed to using his home as a place where "Libyan Christians" could openly practice Christianity. Meanwhile, the Libyan national claimed that she was tasked with persuading fellow Libyans to convert to Christianity. The video footage also included a third local male who confessed to receiving financial support from the US national after joining the organisaiton.

In a related development, a Department of State (DoS) spokesman told CNN that the DoS is aware of reports of a US national being detained by a "militia" in Tripoli on 12 April. The spokesman stated that when a US national is detained overseas, the Ministry works to provide all forms of required assistance.

In response to the DoS spokesman describing the ISA as a militia, the agency issued a statement defending the legality of its institution and outlining its duties.

Analysis/Comment: The incident confirms the sensitivity surrounding the topic of religion in Libya given the religious composition of the Libyan society and the importance placed on Islamic teachings. The development is gaining traction and is currently at the centre of public debate in Libya.

GNU Prime Minister Abdul Hamid Dbeibah held a meeting with Chief of Staff (CoS) Mohammed Al-Haddad and several ministers and discussed the financial conditions of military personnel including the unified salary scale on 12 April. Finance Minister Khaled Al-Mabrouk assured the Defence Minister that all financial procedures had been completed to settle the status of military personnel and implement the unified salary scale for MoD employees.

Bashagha denies deal with Dbeibah to resign

GNS Prime Minister Fathi Bashagha denied rumours of a deal struck with GNU Prime Minister Abdul Hamid Dbeibah to resign from his post in exchange for a position as head of a security institution in an interview with Asharq Al-Awsat on 12 April. Meanwhile, on the removal of Russia's Wagner Group from Libya, Bashagha stated that the latter is a priority for the US and its European allies, stressing however, that their calculations would not be solely focused on this matter.

Al-Zawiya: Al-Selaa allegedly intervenes to defuse Abou Rass-Tajouri tensions

Reports indicate the MoD-affiliated 103 Battalion "Al-Selaa militia" (Al-Zawiya) commander Othman Al-Lahab received Presidential Guard (PG)/Tripoli Revolutionaries Brigade (TRB) commander Ayoub Abou Rass in an unidentified area of Al-Zawiya over the past 48hrs. Reports allege Al-Lahab sought to reconcile between Abou Rass and 777 Brigade commander Haithem Al-Tajouri, though Abou Rass refused the efforts and accused Tajouri of being the sole reason behind divisions within the TRB's ranks and the deterioration of its reputation. Reports allege Abou Rass informed Al-Lahab of his return to Tripoli following coordination with prominent Tripoli-based armed formations including the Stabilisation Support Agency (SSA) and the 444 Fighting Brigade. Of note, reports allege Abou Rass' new armed formation will be located at the World Islamic Call Society.

Comment: Abou Rass' return to Tripoli, if confirmed, could upset the current military balance in the capital that has maintained relative calm.

HoR approves new law regulating LIS ops.

The House of Representatives (HoR) approved a new law (2023) regulating the operations of the Libyan Intelligence Service (LIS), including granting the head of the agency the post of an advisor to the head of state with regard to the country's security and safety who is directly accountable to the head of state. According to the law, the agency will not be subject to any oversight body to maintain the confidentiality of its work, instead a secret oversight committee will be formed by a presidential decree. The agency will consist of a president, two deputies, and a secretary-general, as well as a sufficient number of managers and employees who will undergo a one-year probationary period. Those appointed in the agency cannot hold dual nationality nor have naturalised parents, while the wives of the occupants should not be foreigners unless they hail from an Arab nation.

Benghazi: Scheduled GNU CoS visit

GNU Chief of Staff (CoS) Mohamed Al-Haddad is due to visit Benghazi today to meet with his LNA counterpart to continue discussions on the unification of the military establishment and the formation of a joint force.
