## **SUMMARY**

#### **Key Points**

- Saleh: New gov't to supervise elections
- Security environment stable
- Political tensions continue to escalate

#### **Political**

Whispering Bell continues to assess presidential elections are unlikely in 2023, despite momentum towards the polls. In the current context, Libya stands at the political crossroads of new government announcements.

Political divisions over the way forward in Libya remain centred around the need to form a new government, and whether this must be a brand new executive to supervise the elections, or a government formed via a Government of National Unity (GNU) cabinet reshuffle and/or merger with the parallel Government of National Stability (GNS).

The 6+6 committee tasked with formulating electoral laws kicked off its meetings in Bouznika, Morocco, on 22 May. Regardless of the potential consensus reached during the interparliamentary discussions, it is assessed the electoral laws will require the final approval of the eastern-based parliament, which will likely delay the path towards elections in favour of a new government.

Meanwhile, it is anticipated all stakeholders will continue to pay lip-service to elections whilst pursuing specific political agendas and securing their interests. A key escalation trigger in the next few weeks will be the 6+6 committee's potential publication of electoral laws that compel presidential candidates to resign from their positions and/or exclude specific candidates.

### Security

Stable atmospherics prevail across the country. Political tensions are expected to increase the frequency of sporadic low-impact security incidents across the western region, though the overall operating environment will remain permissive for foreign businesses.

There is mounting evidence to indicate the wave of security incidents in Al-Zawiya is part of a sophisticated anti-GNU campaign to weaken Dbeibah's foothold in the city, expel pro-GNU forces, and make the case for a new interim government. The political nature of the demands by the local protesters lend credence to this assessment.

#### Oil & Gas

Disruptions to production are likely despite evidence the LNA is yet to support a coordinated oil blockade. In his latest visit to Libya, US Central Intelligence Agency (CIA) Director William Burns allegedly reiterated to Haftar the importance of safeguarding oil and gas facilities and production.

# **TRIPOLI**

Report n°6394: Tripoli: 444 Fighting BDE member released

Video footage circulated on 29 May corroborated the release of 444 Fighting Brigade commander Musab Zureik whose brief detention by the Special Deterrence Force (SDF) sparked skirmishes between the latter and the Brigade in central Tripoli on 28 May.

**Analysis/Comment:** Zureik's release significantly decreases the likelihood of tensions resuming between the two sides in the short-term.

Report nº6395: MJI: Benghazi basketball club assaulted

Al-Nasr Club condemned an assault on its basketball team by Mitiga International Airport (MJI) based security upon landing, holding the GNU's Ministry of Interior (MoI) responsible for providing its team with security in a statement issued on 30 May. The incident took place at night on 29 May.

**Analysis/Comment:** The PC's backing of the GNU's military operation in the west coast region is set to increase criticism against the Council both at the levels of the general public and politically.

#### Report nº6396: Al-Furnaj: 444 allegedly raids military HQs

Unconfirmed reports allege the 444 Fighting Brigade raided the headquarters of the Military Prosecutor General in Tripoli, Military Prosecution, and Counter-Terrorism Prosecution. Reports allege the Brigade took possession of documents from the HQs and burned a large number of files in Tripoli's Al-Furnaj area on 29 May.

Analysis/Comment: The incident closely follows the 444 Fighting Brigade's involvement in skirmishes with the Special Deterrence Force (SDF) over the latter's detention of a Brigade member in central Tripoli on 28 May.

#### • **Report nº6397:** Tripoli: Dbeibah & Menfi receive eastern tribesmen

GNU Prime Minister Abdul Hamid Dbeibah received a delegation from the eastern Al-Awaqir tribe at the Prime Minister's Office on 29 May. The meeting discussed several service and social files according to the GNU's Media Office. Dbeibah assured the visiting delegation of his government's keenness to consolidate social cohesion and improve services in the eastern region. For their part, the tribesmen affirmed their support for the GNU to achieve stability and development and praised their efforts to hold successful elections.

Separately, Presidential Council (PC) Head Mohamed Menfi received a delegation of the eastern Al-Obeidat tribe and discussed the latter's role in the Council's national reconciliation project, reunification efforts, and the holding of elections in Tripoli on 29 May.

**Analysis/Comment:** Tripoli's power bloc understands the importance of maintaining a harmonious relationship with Libya's influential tribes given the significant role they play across all fields.

#### Report nº6398: Supreme Court: UN SRSG visit

UN SRSG Abdoulaye Bathily visited Tripoli's Supreme Court on 29 May. Bathily was briefed on the work of the Court and the role of judicial bodies in ensuring compliance with laws and regulations, particularly with regard to the electoral process. Bathily stated that he discussed with the President and members of the Court the judiciary's important role in the electoral process, as well in the field of human rights.

## **NATIONWIDE / GENERAL**

#### Al-Zawiya Coastal Rd: Additional closure

WB sources reported locals from Al-Zawiya closed off the Coastal Road west of Al-Zawiya between Mutrud and Surman in protest of the GNU unmanned aerial vehicle (UAV) strikes targeting the west coast at approximately 1400hrs on 29 May. Sources reported the Coastal Road remains closed as of 0730hrs on 30 May. Of note, the development comes a day after locals from Al-Zawiya closed the Coastal road east of Al-Zawiya.

#### GNU MoD west coast operation 1<sup>st</sup> phase completed

The GNU Ministry of Defense (MoD) commended its Air Force for successfully completing the first phase of its security operation and achieving mission objectives, which included precision airstrikes targeting hideouts across the west coast region on 29 May. The Ministry reported the destruction of 7 boats used by criminal gangs and 9 tanks used for smuggling fuel overseas. The ministry confirmed all precautionary measures are in place to protect civilians and their properties. The ministry announced the commencement of the second phase of its operation, renewing its call on citizens to fully cooperate and remain distant from suspicious sites used by criminal gangs. The ministry noted that it will publish a video statement on the details of the operation's first phase in due course.

#### HoR accuses GNU of settling political scores in Al-Zawiya

House of Representatives (HoR) Speaker Aguila Saleh and his First Deputy Fawzi Al-Nuwairi chaired an open session in Benghazi on 29 May. Saleh called for a statement to be issued by

the HoR notifying UN SRSG Abdoulaye Bathily, Attorney General Al-Siddik Al-Sour, the International Criminal Court (ICC), and the Turkish parliament of the events in Al-Zawiya and Al-Mayah. The HoR argued that the GNU unmanned aerial vehicle (UAV) strikes in Al-Zawiya are being carried out to settle political scores and not to combat smuggling as the GNU claims. The HoR argued the bombing of the residence of Al-Zawiya MP Ali Abu Zreiba confirms the GNU is serving its own political interests.

#### US & UK embassies concerned with Al-Zawiya situation

The US Embassy in Libya stated that it is monitoring with concern the situation in Al-Zawiya amid reports of weapons being used in civilian areas and the potential for further violence, calling on Libyan leaders to de-escalate and take precautionary measures to protect civilians on 29 May. Of note, similar calls were echoed by the UK Embassy in Libya on 29 May.

#### Mali: New footage of kidnapped SA paramedic

A newly-surfaced video of kidnapped South African paramedic Gerco Van Deventer was circulated across media platforms, confirming his detention in Mali by Jamaat Nasr wal Muslimin (JNIM), an affiliate of Al-Qaeda (AQ). Gerco confirms the video is dated 26 May 2023. Gerco can be seen in the video appealing for help to secure his release. Of note, Gerco was kidnapped in Libya whilst working for a private security provider in 2017, and later smuggled to Mali. His presence in Mali was only confirmed in Jan 2023.

#### Wershiffanah commander condemns GNU UAV strikes

55th Brigade commander Moammar Al-Dawi (Wershiffanah) condemned GNU unmanned aerial vehicle (UAV) strikes in the west coast region that killed one of his members on 28 May. It will be recalled that Al-Dawi shifted loyalties and sided with GNU Prime Minister Abdul Hamid Dbeibah following the GNS' third failed attempted entry into Tripoli in Aug 2022, after initially supporting Bashagha-led GNS forces.

#### Benghazi: Haftar receives UK Ambassador

LNA commander Khalifa Haftar received UK Ambassador to Libya Caroline Hurndall at the LNA HQ in Benghazi on 29 May. The meeting discussed recent political and security developments, including creating a suitable environment for elections to be held in 2023 according to the LNA's Media Office. Of note, the meeting comes a day after Haftar received UN SRSG Abdoulaye Bathily.

#### Sabha: LNA/GNS visit

A delegation led by LNA Tariq Ibn Ziyad Brigade commander Saddam Haftar and GNS Prime Minister Osama Hammad alongside deputy Salem Al-Zadma, visited Sabha on 29 May. The visiting delegation was received by Sabha Military Region commander, Sabha Security Directorate members, and sheikhs of the city. The delegation inspected several service and

development projects implemented by the GNS and the Brigade, as well as several administrative headquarters and government buildings.

#### Al-Ajaylat: Municipal elections

The Central Committee for Local Elections (CCLE) commenced municipal elections in <u>Al-Ajaylat</u> and opened the voter registration on 29 May. Of note, CCLE announced the preliminary results of the elections for Zuwara and Dirj municipal councils held on 27 May.

#### 6+6 reportedly agree on eligibility of military officials candidacy

Unconfirmed reports on 30 May allege the 6+6 committee tasked with formulating electoral laws has come to an agreement on the candidacy of dual nationals and military officials, as well as a timeline for elections. According to these reports, the committee agreed to hold parliamentary elections by Dec 2023 and presidential elections the following month in Jan 2024. The committee allegedly agreed to form a new government with a 6-month limited mandate to hold the elections. More importantly, the committee will allegedly allow military officials to run for office and regain their positions if they do not win, and dual nationals to run provided they renounce their second citizenship if they reach the second round or win the elections.

A final announcement by the 6+6 committee is identified as a trigger for escalation. Localised flashpoints are likely across government buildings in Tripoli and other high-profile landmarks known to host political figures. Still, the overall operating environment in Tripoli will remain permissive throughout these heightened political tensions.

 Report nº6393: Al-Zawiya Refinery closed, GECOL warns of blackout

Armed individuals loyal to MP (Al-Zawiya) Ali Abu Zreiba halted gas and fuel supplies feeding Tripoli power stations by closing valves at Al-Zawiya Refinery, in demand of the GNU Prime Minister Abdul Hamid Dbeibah's dismissal over the recent UAV strikes in the city at approximately 1700hrs on 29 May. The General Electricity Company of Libya (GECOL) warned of a major power outage across the majority of the country in the coming hours.

Meanwhile, Abu Zreiba stressed that he will not allow oil and gas operations to resume at the refinery until Dbebah is dismissed, noting that the closure was orchestrated by sheikhs of the western region. Abu Zreiba echoed GECOL's warning of nationwide blackouts.

In the same context, Al-Zawiya's First Support Force commander Mohamed Bahroun aka "Al-Far" condemned the pipeline closures and voiced his support for the GNU's operations in the west coast region on 29 May. Al-Far stated that the development stands as a "desperate attempt" by criminal gangs to disrupt the GNU's security operation.

**Analysis/Comment:** The development is significant given it marks what could prove to be the beginning of a series of nationwide oil and gas disruptions in protest of the GNU's security operation in the west coast region and in a bid to unseat Dbeibah.

#### **B – Fairly Reliable:**

This information is probably true. This information is possibly true. B is "Fairly Reliable" for "minor doubt". It is reported one or more mostly credible publications, and if an author is listed we have no reason to suspect them to be biased on this subject. The reporting is primarily based on verifiable information. The information is mostly consistent with everything our team knows about this subject, but may contain new or surprising information given credibility on the strength of the publication or author.

#### C - Unreliable:

This information is probably false. This information is almost certainly false. "not usually reliable" for "significant doubt," and "unreliable" for "Lacking in authenticity, trustworthiness, and competency; history of invalid information". It appears in social media or an unreliable publication, and may be written by an author that is not known to us or is known to be less reliable. The reporting is thin, largely dependent on anonymous sources or unverifiable accounts from social media or limited access areas. The information is consistent enough with our knowledge of the subject to be possible, but contains sufficient discrepancies to make it seem unlikely.
