## SUMMARY

#### **Key Points**

### Political

Whispering Bell continues to assess presidential elections are unlikely in 2023, despite momentum towards the polls. In the current context, Libya stands at the political crossroads of new government announcements. Political outcomes rest on the House of Representatives (HoR) and High Council of State's (HCS) adoption of the political roadmap and electoral laws produced by the 6+6 committee, which stipulate presidential elections must be held within 8 months of the ratification of the electoral laws.

However, the HoR fell short of ratifying the electoral laws produced by the 6+6 committee during its session on 10 July after an altercation between MPs. The dispute was allegedly sparked by MPs closely aligned with Haftar. Against the backdrop of tensions within the HoR, HCS members proposed ratifying the electoral laws produced by the 6+6 committee and sending them directly to the High National Election Commission (HNEC) to move ahead with presidential and parliamentary elections. For its part, the HCS adopted the roadmap for the implementation of the electoral laws in its session on 11 July, albeit with some technical observations. Still, the ball remains in the HoR's court to ratify the laws. Instead, the HoR appears to be laying the groundwork for another roadmap that aims to form a new government.

On 10 July, HoR Speaker Aguila Saleh presented to his deputies a mechanism to form a new limited government tasked with overseeing the transitional period until elections are held. According to the proposal, the process of forming a new government begins with opening the door for the candidacy for the post of Prime Minister for a period of 15 days from the date the roadmap is approved. The winning candidate is required to obtain 15 recommendations from the HoR and 12 recommendations from the HCS and the government is considered to have gained confidence once the Prime Minister obtains the required votes. The newly-elected Prime Minister must then present his cabinet and government programme to the HoR within 20 days from the date of his assignment.

Given the stalemate, the UN Support Mission in Libya (UNSMIL) will reportedly convene key Libyan stakeholders over the next few days to reach a settlement on the electoral laws.

### Security

Stable atmospherics prevail across the country. An uptick in tensions was recorded along the coastal road westwards from AI-Zawiya to Ras Ajdir. Travellers are advised to exercise caution.

### Oil & Gas

The threat of an LNA-induced oil blockade has significantly increased across all scenarios and is now assessed a likely in the next three months. Against the backdrop of mounting political tension, backchannel negotiations to form a new government, and diplomatic pressure, the LNA may be compelled to utilize the "oil card" to raise its bargaining leverage in the medium term (3-6 months). The LNA is unlikely to directly sanction a blockade but may instead do so by exploiting local grievances to restrict oil exports and exert pressure on the GNU.

## TRIPOLI

#### Report nº 6523: Abu Salim/Hadba: Firework explosions

WB sources reported the sounds of explosions from fireworks in Tripoli's <u>Abu</u> Salim and <u>Al-Hadba</u> Al-Mashro' areas at approximately 0000hrs on 18 July.

**Analysis/Comment:** The motive is unknown, though Al-Ahli Football Club fans have been celebrating their latest victory with fireworks across various areas of the capital over recent days.

#### Report nº 6524: Tajoura: Medical staff strike

Medical staff at <u>Dermatology Hospital</u> in Tripoli's Tajoura area entered a general strike as of 17 July in protest of an unidentified armed group opening fire on a fellow colleague on 16 July.

Analysis/Comment: No further confirmation.

#### **Report nº6525:** Talks on reopening of Oman & Iran embassies

The GNU Ministry of Foreign Affairs announced that talks between Director of the Department of Administrative and Financial Affairs Rashid Abu Ghafeh and an Omani diplomatic delegation led by Oman's Ambassador to Tunisia Hilal bin Abdullah Al-Sanani discussed the necessary arrangements to reopen the Embassy of Oman in Tripoli on 16 July.

#### **Recommendations**:

Continue to monitor details surrounding the reopening of foreign embassies in Tripoli.

consular services, noting that the embassy's building is currently being prepared and organised on 17 July.

**Analysis/Comment:** The aforementioned developments coincide with a number of foreign embassies reopening their doors in Tripoli instead of operating from neighbrouding Tunisia thanks to an improvement in Tripoli's overall security environment, particularly over the past year.

#### Report nº6526: Senussi trial postponed again

Local reports indicate the trial session of Gaddafi-era Intelligence Chief Abdallah Senussi scheduled to take place in the afternoon on 17 July was postponed for a fifth time until 07 August. Senussi's lawyer stated that despite the presence of the lead judge, other court members and representatives of the public prosecution as well as the defendant himself were absent.

**Analysis/Comment:** Seenussi's defense team has previously accused the executive authority of preventing the attendance of their client in previous sessions.

## **NATIONWIDE / GENERAL**

#### AI-Ajaylat: Unidentified military gathering

Reports indicate an unidentified military gathering was monitored in AI-Ajaylat's <u>AI-Shabika</u> and <u>AI-Jadida</u> areas in the evening on 17 July. Unconfirmed reports allege the military gathering is linked to the arrest of two members of an armed formation from AI-Ajaylat by the 103 Battalion "AI-Selaa" (AI-Zawiya) south of AI-Ajaylat on the same day.

#### Ajdabiya court nullifies municipal elections

The Ajdabiya Court of First Instance issued a ruling nullifying the results of the municipal elections in Ajdabiya after a list supported by AI-Azywa tribe won on 17 July. The Court accepted the appeal submitted by another list supported by AI-Furjani tribe from which LNA commander Khalifa Haftar's son-in-law hails.

**Comment:** It will be recalled that the list of LNA commander Khalifa Haftar's son-in-law, Ayoub Al-Ferjani, secured second place with the list of Moftah Bukhmada proving victorious. In protest of his loss, Al-Ferjani ordered the cancellation of the municipal elections and threatened Bukhmada with imprisonment. The development highlights the level of control the LNA enjoys in areas under its control, including influence over the judiciary.

#### Ras Ajdir: Security reshuffle allegedly commences

Unconfirmed reports allege the process of replacing the existing custom authorities hailing from Zuwara and Al-Zawiya at the Libyan-Tunisian <u>Ras Ajdir</u> border crossing point (BCP) has commenced. It will be recalled that GNU Prime Minister Abdul Hamid Dbeibah instructed the Ministry of Interior (MoI) to replace all members of the security services and employees at the <u>Ras Ajdir</u> BCP in a decision issued on 08 July.

#### Saif Al-Islam political team denounce LNA

The political team of Saif Al-Islam Gaddafi issued a statement on 17 July denouncing LNAsanctioned "arbitrary arrests" of the leaders of the "Together for the Homeland" party and political activists including faculty members, media professionals, journalists, and tribal sheikhs and notables. The statement noted that Gaddafi's political team as well as all political parties operate freely in the western region without facing threats, intimidation, or harassment. The statement denounced the LNA's intimidation of the House of Representatives (HoR) Speaker and MPs, accusing the LNA of preventing HoR Speaker Aguila Saleh from chairing this week's official session with the aim of disrupting the electoral process.

**Comment:** The statement could exacerbate existing tensions between the pro-Gaddafi bloc in Libya and the LNA, including in Sirte where tensions between the two sides are common.

#### Berniq Airways operates BEN-DWC flight

Berniq Airways conducted its first flight from Benghazi's <u>Benina International Airport</u> (BEN) to Al Maktoum International Airport (DWC) on 17 July, making the commencement of the first route between Libya and Dubai following a years-long hiatus. It will be recalled that Berniq Airways announced the launch of the BEN-DWC route on 04 July. Similar announcements of the resumption of flights between the two countries have been made in the past, but failed to materialise.

#### GNU declares public holiday

GNU Prime Minister Abdul Hamid Dbeibah declared 19 July and 20 July a public holiday on the occasion of the Islamic New Year 1445 in a decision issued on 17 July.

#### Shakshouk: Road closure

Reports indicate the closure of Bottom Western Mountains Road links <u>AI-Azzizziya</u> with <u>Nalut</u>, specifically at <u>Shakshouk CP</u> by locals by burning tyres in the afternoon on 18 July. The protesters were denouncing the recent Mol decision to restructure the security directorates in the western mountain region on 13.

• *Report n°6527*: Benghazi: NOC launches graduate training programme

National Oil Corporation (NOC) Chairman Farhat Ben Guedara announced the launch of a training programme for over 7k graduates from across Libya in an event held in Benghazi on 17 July. Ben Guedara stated that those enrolled will receive a monthly allowance of 1k Libyan Dinars (LYD) and will be appointed across affiliated oil and gas companies upon successful completion.

**Analysis/Comment:** Given oil and gas graduates hold routine protests outside the NOC HQ in Tripoli in demand of job opportunities within the oil and gas sector, it is likely that the aforementioned initiative will spark similar protests in protest of bias in terms of those selected for the programme.

#### C – Unreliable:

It appears in social media or an unreliable publication, and may be written by an author that is not known to us or is known to be less reliable.
