RENEWAL ACCOMODATION AGREEMENT For Italian Embassy in Tripoli

This Agreement refers to the accommodation contract signed on May 15th 2020 through which LAILAC Trading & Consulting Co Ltd provides the Italian Embassy in Tripoli with the exclusive use of the Al Waddan Hotel in Tripoli and renewed with the Addendum signed on 02.05.2021 from 15th May 2021 until 27th May 2022.

The parties agree to renew the validity of this agreement starting from 28th May 2022 to 27th May 2023.

RATES

Prices are quoted in Euros. The Company shall offer the Embassy a fixed rate for the 37 guest, and then different rates for the next number of guests as shown in the table below. This will be for the duration of one year (12 months) and may be extended for another year (12 months) upon mutual agreement.

Terms and conditions

1. Liability

1.1 Each party is fully liable for its non-performance or undue performance unde this Agreement. The Company shall only be liable for breach in case of gross negligence or willful default or misconduct. In case of breach of this Agreement, the Company shall only be obliged to compensate for the direct loss and damage resulting from this breach.

1.2 The Embassy shall be liable for the fulfilment of any payment obligations of guests

2. Early Termination Clause:

The Embassy is entitled to terminate this agreement providing the company 30 days written notice of such termination.

Diplomatic Clause: In the event of any circustances beyond the control of either Party, the Embassy shall be entitled to terminate or suspend this Agreement until the disappearance of the said circumstances.

3. Validity of the Agreement:

- 3.1 The Agreement will take effect as of the date when it is signed by both Parties and shall remain effective for one year (12 months) and may be extended for another year (12 months).
- 3.2 Each Party is entitled to early termination of this Agreements for breach, subject to written breach notice to the other Party describing the breach and requesting remedial action within an appropriate deadline. Should the defaulting Party not have corrected the breach within

the set deadline, in case of payment obligation within 10 (ten) days from receipt of the notice of breach, the non – defaulting Party send a termination notice upon the receipt of which by the defaulting Party this Agreement shall end.
