5. Explanation of the grounds which led to the inspection of the vessel believed to be carrying arms and/or related materiel:

Based on the information gathered by EUNAVFOR MED IRINI from various sources and also provided by Member States, MV MATILDE A was suspected of transporting weapons and related material in violation of the arms embargo on Libya.

According to intelligence from MS, MV MATILDE A is a vessel that undertakes frequent port callings in Libya and in countries suspected of illegal arms trafficking or military support to factions involved in the Libyan conflict. The most frequent port callings of the vessel are Turkish (BORUSAN, AMBARLI, YARIMCA, GEMLIK, IZMIR) and Libyan (MISURATA, AL KHOMS, TRIPOLI).

The vessel departed from the port of AMBARLI on 18th May 2021 and was directed to MISURATA, in order to arrive on 21st May 2021.

This assessment indicates that there were reasonable grounds to suspect that MV MATILDE A could have been involved in the illegal weapons trafficking and that a further investigation had to be conducted on board the vessel, in accordance with UNSCR 2292 (2016) and 2526 (2020).

6. Good faith efforts made by Member States and regional organizations to obtain the consent of the vessel's Flag State prior to using the authority

EUNAVFOR MED IRINI submitted a request for the Flag State's consent to inspect MV MATILDE A to the REPUBLIC OF TURKEY - MINISTRY OF FOREIGN AFFAIRS. In particular, the consent request was sent on 19th May 2021 at 0900Z by email (ANNEX A) to the following competent Ministry of Foreign Affairs of the Republic of Turkey points of contact:

- Head of the Maritime Department
- Duty Officer of Ministry of Foreign Affairs
- Republic of Turkey Maritime Rescue Coordination Center (MRCC).

At 0938Z on 19 May 2021, EUNAVFOR MED IRINI received an email from the Ministry of Foreign Affairs of the Republic of Turkey – Head of Maritime Department communicating that "To Whom It May Concern: I hereby confirm that MATILDE A (IMO 9292448) does fly the flag of Turkey and convey that the Turkish Government does NOT grant flag-state consent for any inspection of this vessel" (ANNEX B). Consequently, on 19th May 2021, at 0950Z, EUNAVFOR MED IRINI informed by e-mail the Head of the Maritime Department that "Operation EUNAVFOR MED IRINI has received the Flag State denial in relation to the request for the inspection in accordance with UNSCR 2292 (2016) and UNSCR 2526 (2020). Therefore, the Operation, respecting the Flag State Authority and international law, will NOT proceed with any further actions".

7. Description of the event

Based on denial of Flag State Consent Operation IRINI did not take any measures to proceed with an inspection in accordance with UNSCR 2292 (2016) and international law.

8. Closing remarks.

EUNAVFOR MED IRINI was acting according to UNSCR 2292 (2016) and UNSCR 2526 (2020). The reasonable grounds for the inspection were based on information collected by the Operation from various sources and from Member States. Due to the Flag State denial from the Ministry of Foreign Affairs of the Republic of Turkey - Head of Maritime Department EUNAVFOR MED IRINI could not proceed with the inspection.

Reason for request: the Operation Commander of operation EUNAVFOR MED IRINI presents its compliments to the REPUBLIC OF TURKEY – MINISTRY OF FOREIGN AFFAIRS and has the honour to request, acting in accordance with UNSC Resolution 2292 (2016) and 2526 (2020), the authorisation to inspect MV MATILDE A, flagged in TURKEY, IMO number 9292448.

The vessel is suspected of violating the arms embargo on Libya.

7. According to UNSCR 2526 (2020) and UNSCR 2292 (2016) (par. 3-6), Operation EUNAVFOR MED IRINI naval assets are allowed to inspect, seize, dispose and take further actions against vessels going to and coming from Libya which they have reasonable grounds to believe are carrying arms or related materiel to or from Libya directly or indirectly. Actions are admitted providing that good faith efforts are made by Member States and regional organisations to obtain the consent of the vessel's flag state prior to using the authority.

- 9. Should you confirm the ship flies your flag, you are hereby asked to authorise Op. EUNAVFOR MED IRINI to conduct the following actions:
- Inspection of the vessel (stop, board, visit and search);
- If it is confirmed that the vessel is carrying arms and related materiel, to seize and dispose such items;
- Divert the ship to harbour.
- 10. The request is made on the basis that action taken pursuant to any authorization provided will be carried out only by warships or military aircraft, or other ships or aircraft clearly marked and identifiable as being on government service and authorized to that effect.
- 11. A reply is requested within 4 (four) hours of the sending of this message; after mentioned deadline, intervention takes place under the provisions of UNSCR 2526 (2020) and UNSCR 2292 (2016).
